# About NECA

The National Electrical and Communications Association (NECA) is the peak industry body for Australia's electrical and communications contracting industry, which employs more than 165,000 workers and delivers an annual turnover in excess of \$23 billion. NECA represents the best interests of over 5,255 electrical contracting businesses across all Australian States and Territories.

NECA has been advocating for, and on behalf of, the electrotechnology industry for over 100 years. We aim to help our members and the wider industry to operate and manage their business more effectively and efficiently while representing their interests to Federal and State Governments, regulators and principal industry bodies such as the Australian Chamber of Commerce and Industry (ACCI) and Standards Australia.

NECA is strongly committed to supporting the next generation of electrical and communications contractors. Working with our partner Registered Training Organisations (RTOs) and Group Training Organisations (GTOs), NECA provides employment and ongoing skills development for approximately 4,800 apprentices across Australia. The majority of these apprentices get the opportunity to gain work experience with NECA's members through our group schemes. Our training arm delivers training options for an additional 4,000 qualified electricians across the industry, providing technical advice and business skills training along with business development and marketing training for managers.

NECA also manages and promotes the industry wide annual Excellence and Apprentice Awards, a scholarship program, the NECA Foundation and the Alternative Pathways Project.

The Australian Cabler Registration Service (ACRS) is a wholly owned and operated subsidiary of NECA, licensed by the Australian Communications and Media Authority (ACMA). ACRS is the second largest Registrar of Cablers in Australia.

# **CEO's Report**

A new energy is building in the electrotechnology sector. As technologies have evolved, so too has the electrical and communications industry to meet these changes head on.



Year on year, we see our members push the boundaries of what is possible in solar, battery storage and renewables as well as data communications, IoT and automation.

As we close out the decade and look forward to 2020, we see our industry remaining strong, yet flexible, and importantly, resilient in the face of constant government, regulatory, economic and technological change.

I would firstly like to thank our members who have volunteered their time and resources to NECA, as well as to all our dedicated staff across the country. I would also like to recognise and thank our dedicated sponsors. The commitment and loyalty of all our industry business partners is invaluable to NECA and our sector, and we are grateful for their continued support and I thank you all.

2019 highlights to be proud of include:

 NECA continues to strengthen its presence across the country with more than 60 employees in our Chapter offices. This does not include those working in the various GTOs, RTOs and controlled entities, which would be at least the same number again.
 NECA and its entities now have considerable assets which exist for the benefit of members and the industry.

- NECA trains approximately 4,000 apprentices through our RTOs and GTOs – a figure that as an industry, we should be proud of, but one that we are actively working to increase to support industry demand for skilled tradespeople.
- NECA Membership numbers now exceed 5255

   testament to our unwavering focus on member issues and improving our services.
- We had a number of successes engaging with media and key stakeholder including Federal and State Governments, policy-makers and regulators, on the foremost concerns affecting our members and industry.

In 2019 we continued to proactively advocate on behalf of members focusing on:

# Non-Compliant Building Products – also known as the 'Cancer of the Construction Industry'.

This is a problem that has been allowed to fester by successive Federal and State Governments. We will continue to push government for an outcome on non-confirming building products including a uniform national approach, tough legislation and policing of Australian standards.

Non-conforming products threatens every consumer. The question we ask is 'What will it take for this to be a priority for Government?'

# Security of Payments Laws – to ensure that contractors are no longer seen as de facto financiers for head contractors.

While we are seeing change on a state level, NECA is advocating for a national approach. With countless examples of builders going under due to no-fault of sub-contractors, protections and measures must be immediately introduced to limit any further detrimental impact to this sector.

NECA calls for levels of accountability, transparency and fairness that safeguard sub-contractors as recommended by the Murray Review, which NECA actively contributed to, now come to pass.

# Vocational Education and Training – where we continue to actively promote the benefits of a career pathway in the trades.

We are starting to see the conversation on careers change, albeit slowly, at the highest levels of Government, with the Joyce Review mapping out a path for a top-down approach that will boost the status of VET education.

Initiatives such as establishing the National Careers Institute, which would provide better careers information to students and enable them to make informed decisions about their futures, are important steps to turning the tide. Critically, alongside this, we need to see a bottom up change in attitudes that recognises the value of an apprenticeship to individuals and the broader economy. The consequences of not doing so are simply too great. Skills shortages across the Australian economy are reaching crisis point when we have more infrastructure planned than ever.

In line with our recommendations, NECA has been front and centre supporting Australia's training needs for the past two years through the Federal Government's Industry Specialist Mentoring for Australian Apprentices (ISMAA) program. The scheme has been designed to increase the retention rates of apprentices in the first two years of training, and as a result, improve completion rates and increase the supply of skilled workers in the Electrotechnology industry sector.

Through NECA's ISMAA program we have provided support for more than 3,500 apprentices across Australia achieving success rates of around 90% through regular one-to-one contact with industry mentors.

In 2019 NECA also partnered with State Governments including the Queensland Government to promote electrotechnology and electrical services careers to young people, focusing on the '9 *Key Reasons to Become an Electrician*'. Part of the Advancing Apprenticeships Fund, NECA's Program assessed young people's suitability for an electrical apprenticeship as well as offer real opportunities by connecting aspiring apprentices with contracting businesses. This year, the outstanding work of NECA members was recognised at the industry's sell out National Excellence and Apprentice Awards held at the Howard Smith Wharves in Brisbane. We would like to thank the Hon. Steve Irons MP, Assistant Minister for Vocational Education, Training and Apprenticeships for sharing a personal account of his career as a tradie and the Government's vision for VET.

Also supporting members, our National Conference on Hamilton Island brought together 330 members and industry representatives. Thank you to everyone that attended - we hope to see even more members in 2020 when the NECA conference lands in Darwin.

NECA would in particular like to acknowledge the invaluable contribution our sponsors make to the Excellence Awards, National Conference and the electrotechnology industry as a whole. Thank you.

Finally, during 2019 NECA achieved a notable historic milestone with our National Council voting to introduce a streamlined, modernised and transparent set of rules. This positive change will position NECA well as we head into our second century. Thank everyone who has been involved in the development of the rules over the last two years. In particular, I'd like to acknowledge the late Alan Brown who was a champion of this project.

# Policy And Advocacy

As the leading voice in the electrotechnology industry, NECA is strongly committed to proactive and ongoing policy reform, research and advocacy on behalf of our members and the broader building and construction sector.

Throughout 2019, NECA made representations to all levels of Government, including elected Members of Parliament and Government agencies, across the country. We commenced working with the newly elected Federal Government, and several newly elected State Governments.

We continue to advocate evidence-based research cutting-edge policy and strategic initiatives to address key issues and priorities. Our influence and efforts are making a positive contribution that shapes policy reform and progressive change for Australia's electrical and communications contractors. The prevailing themes across the Building and Construction sector during 2019 that NECA has been actively advocating on include:

- Non-compliant building products also known as the cancer of the industry – improving quality and assurance across the sector
- Security of Payments laws to ensure that contractors are no longer seen as de facto financiers for head contractors
- Vocational Education and Training where we continue to promote the benefits of a career pathway in the trades and encourage a more diverse workforce
- Taxation reform and red-tape reduction to support small and family-owned businesses.

# Industry Profile


More than 1,500 contractors and their employees completed NECA's 2019 Market Monitor survey, providing and overview of current trends in the sector. Survey respondents shared insights on their business, purchasing practices and general market outlook. The survey focused in on compliance, the impact of digital and new technologies and the perceived influence of the end-customer.

From the survey this year, it is clear the electrical industry is in a state of rapid technological change – perhaps at a rate not seen before in recent history.

This is a challenging time to be a contractor, due to the emergence of these new technologies, but equally is a time for industry leaders, wholesalers and manufacturers to step up.

# Nature of the Work

Residential and commercial projects continue to provide the mainstay of work for most electrical contractor businesses, regardless of size, with maintenance and renovation or refurbishment projects a prominent source of business. Compared to previous years, companies appear to be relying less on a single type of work for much of their revenue and are instead branching out.




# Sources of Work by Company Size


# Sources of Work by Location

Businesses undertake a spread of work, however almost a quarter of businesses, regardless of size, derive their income from maintenance related activity.



# **External Factors for Concern**

Contractors feel that external factors outside of their control will assert the greatest influence on their future business. Concern around general economic conditions and competition from other business remains high, but it is concerns about the cost and availability of skilled labour, and government legislation that has been growing year on year.

# Member Sentiment



Smart technology, IoT and automation are predicted to have an increasing impact on the industry, with around one third of contractors gearing up for this shift. Solar energy, battery storage and renewables also remain top of mind. However, at this stage these anticipated changes in the industry are not having any noticeable impact on the number of companies choosing to specialise in these areas.

Interestingly, contractors feel that the greatest threat to technological change in the industry is through the purchase and installation of poor quality, non-compliant products and (perceived) growing numbers uncertified or inexperienced tradespeople. They also acknowledge the skills and labour gaps in these emerging technological areas.



The ability to conduct business online continues to transform the way the electrical industry operates, especially for younger contractors. More and more contractors are using social media as a business tool, with two thirds using Facebook, and one quarter using Instagram.

This year 80% of survey respondents said they research product information online, with almost one third of businesses now ordering supplies online. The new technology gap is in ordering apps - 8% currently use an app to make orders, but 20% would like to be using an app.



# We're more optimistic about the future

Optimism for future work remains high among survey respondents, with pessimism and concern for future work decreasing compared to previous years. High levels of optimism are most noticeable in bigger businesses (with over 5 employees).



When choosing which brand of product to purchase, compliance is key. Contractors feel confident they understand compliance and the risks that come from not using compliant products, however a majority feel that their end-consumers do not understand compliance.

Unsurprisingly, there is a high level of confidence among contractors that buying from trusted wholesalers will ensure they have compliant products.



# The knowledge gap is widening

Half of contractors surveyed feel that their endconsumers are more knowledgeable than they used to be, however contractors expressed that this makes their job more difficult. According to those surveyed, there appears to be a growing gap in end-consumer knowledge levels, from the technologically illiterate to tech-savvy early adopters, and contractors are finding it challenging to communicate and converse across all levels of knowledge.

# Apprentices

Apprentices are the future of our industry and a significant focus for NECA, and our members.

NECA training organisations across Australia provide skills development and work experience for approximately 4,800 apprentices and maintained over 90% completion rates across these training facilities. To improve the delivery and appeal of apprenticeships, NECA has continued to work with the Federal and State and Territory Governments to deliver a number of industry-led pilots and programs to identify alternate training approaches to improve the skills, industry-readiness and diversity of apprentices and to better promote the benefits of a career in the sector.

# **Mentoring Apprentices**

Mentoring is recognised as critical to the successful completion of a trade qualification.

NECA has been actively involved with the Industry Specialist Mentoring for Australian Apprentices (ISMAA) program to increase the retention rates of apprentices in the first two years of training, and as a result, improve completion rates and increase the supply of skilled workers in the Electrotechnology industry sector. Through NECA's ISMAA program we have provided support for more than 3,500 first and second year apprentices across Australia over the past two years achieving success rates of around 90% through:

- developing relationships with apprentices
- personalised meetings
- keeping apprentices informed about opportunities relating to their apprenticeship
- liaison with registered training organisations (RTOs) regarding training
- providing support and advice
- being available to talk to apprentices and trainees about any issues they are having.

The ISMAA program demonstrates the great value of mentoring in keeping apprentices engaged.



### Engaging the next generation

In 2019 NECA also partnered with the Queensland Government to promote electrotechnology and electrical services careers to young people, focusing on the '9 Key Reasons to Become an Electrician'.

Part of the Advancing Apprenticeships Fund, NECA's Program assessed young people's skills and whether they would be suited to an electrical apprenticeship.

The program was designed to encourage more Queenslanders to consider an electrical apprenticeship, as well as offer real opportunities by connecting aspiring apprentices with contracting businesses. Since its inception, the program has been embraced by local businesses seeking pre-registered candidates for apprenticeships as well as those teachers instructing the TAFE Certificate II in Electrotechnology as a gateway for their students into the industry.

Success in shortlisting suitable candidates for electrical apprenticeships is credited to the use of an industry-specific Harrison Assessment Tool, developed by NECA in conjunction with the electrical industry. More than 80% of those completing the assessment were identified as being suited to a career in electrotechnology, and are on the pathway to securing an electrical apprenticeship.

#### Building facilities for the future

Improving the delivery and appeal of apprenticeship, NECA continues to expand its training capabilities across the country through the addition of new training facilities including in:

- Chullora, New South Wales
- Fyshwick, Australian Capital Territory
- Joondalup, Western Australia

This adds to the current network of training facilities location in Queensland, South Australia and Victoria.

# NECA Foundation

Established in 2006, the NECA Foundation is a registered charity that supports education and career development initiatives in the Electrotechnology industry. 2019 saw the return of the popular Site-Office-to-Head-Office course, which equips electricians with the management skills required to thrive in business leadership roles.

Many future industry leaders participated in the four-day course this year, which will help them transition from site management roles to senior management at some of Australia's leading electrical contracting firms.

During NECA's National Conference on Hamilton Island the Foundation held a fundraising dinner, with money raised going to support the Foundation's important work in 2020. In 2020 the Foundation will expand its course offering to include a Business Succession program that will see NECA engage with electrical contractors across the entire business and contracting career lifecycle.

The Foundation will also launch a new website, which will include an industry charge-out calculator; a tool developed for the industry, by the industry and available to all.

# Queensland Chapter

NECA Queensland Chapter has grown to almost 400 members, employing around 4,000 electrical professionals and purchasing more than \$400M of electrical equipment. After a number of peak years, the construction industry in Queensland experienced a considerable slowdown in 2019 with declines in both new residential dwellings and commercial projects. This has had an impact on many electrical contracting businesses as well as employment opportunities.

While we have been riding out this slowdown, we are on the cusp of seeing a number of major infrastructure projects get underway and anticipate a turnaround in 2020.

Projects in the pipeline for south-east Queensland include Queen's Wharf Brisbane, Brisbane Metro, Cross River Rail project, West Village and Herston Quarter redevelopment to name a few, we anticipate seeing a turnaround in 2020.

Regional areas of the State are also benefitting from a significant pipeline of construction projects, including the Haughton River Dam in Townsville, Shoalwater Bay defence training area expansion in Rockhampton and a number of tourism assets in Cairns.

These major projects will not only boost confidence locally, but also give the electrical industry an opportunity to showcase innovation.

# Highlights and initiatives

2019 has seen a number of changes that have had an impact on our industry:

- From 1 January, the Electrical Safety Office (ESO) tightened the rules around contractor licensing so that all new Qualified Technical Persons (QTP) and Qualified Business Persons (QBP) need to undertake mandated training courses;
- The latest version of the Wiring Rules also became fully operational from 1 January after the transitional period, meaning all future jobs need to be completed to the new rule book;
- Our member services team added more than 100 toolbox talks to our website as well as a new staff induction package, desktop audit package and a number of new SWMS to our NECASafe program, including SWMS for working with Silica;
- New CRM and finance systems were implemented, making it easier to communicate with NECA members;
- New Security of Payment Act legislation came into force, introducing significant changes to both claimant and respondent rights and obligations with respect to payment claims under construction contracts.

# **Training and Careers**

2019 was a big year for the NSW Chapter during which our different business units moved into our new purpose-built headquarters in Chullora, along with our apprentice training program. Opened by The Hon. John Barilaro, Deputy Premier, Minister for Regional New South Wales, Industry and Trade, the Centre of Excellence will further collaboration to benefit members, as well as apprentices who train at the Centre.

Meanwhile, the ACT saw the opening of its own state-of-the-art Centre of Excellence where the next generation of electricians will be equipped with the skills to lead the industry in the future, benefitting members across the territory.

In addition to new premises, the NSW and ACT Chapters undertook a major digital project, implementing a number of solutions across Customer Relations, Finance third party payments and a new membership portal, aimed at improving the member experience and automating Chapter business processes.

NECA has also expanded its membership services division to better support members through our telephone advisory service.

### **Training and Careers**

# Victoria Chapter

It is with great pleasure to share my first NECA Victoria review. There is a renewed energy and momentum gathering in Victoria, with several initiatives implemented recently and next year looking equally exciting.



Victoria has the fastest growing population nationally. This rapid growth over the past five years is evident with the Melbourne housing price boom, and the Victorian Government is working to keep up with demand for public infrastructure.

To support this, the Government has committed \$30 billion in infrastructure investment, with these projects anticipated to positively impact our industry over the next 12-18 months. However, many are predicting this will be accompanied by an industry wide skills shortage.

This is in contrast to the past few years where electrical contractors in Victoria have experienced weak demand in several key markets including domestic single dwelling and multi-residential as well as non-building infrastructure related activity. Rising investment in industrial building construction during this time did however provide a much needed counterbalance. Demand from institutional construction is expected to increase in the first half of 2020.

# **Highlights and Initiatives**

2019 has been a breakthrough year for NECA Victoria in the Technical Advisory Services space. Our Health and Safety Management System was completely overhauled to ensure it is compliant with current WHS regulations, with a Certificate of Compliance issued by TQCSI. We also welcomed Peter Tsoubos to NECA as HSEQ Manager.

The Technical Team answered and resolved close to 1,000 Technical Hotline and Inbox gueries. The Technical Knowledge Base (TKB) is continuously updated to reflect changes in Australian standards and industry requirements. In 2019 there were over 700 new users added to the NECA Victoria TKB, and over 6,000 searches conducted. Due to the demand, NECA Victoria also welcomed Michael Weekes. who joined us to expand our technical capability. Our Workplace Relations and Industrial Relations service continues to be in high demand, resolving close to 4,000 enquiries across key issues affecting members such as termination & dismissals, bullying and safety matters, performance/conduct, under-payments and enterprise bargaining agreements. The team is also well versed in emerging issues such as labour hire licensing, industrial manslaughter and mental health.

During 2019 our team has taken the time to understand our rich and diverse membership. We have developed a NECA Victoria Member Journey and Member Engagement blueprint, improved our account management approach across both metropolitan and regional areas of Victoria, adopting a cultural mind-set of delighting our members. We have also identified gaps and opportunities to build value in key areas of the business. We will continue to check-in with our members and provide them with meaningful opportunities to shape the NECA offering.

# **Training and Careers**

NECA Education & Careers (E&C) in Victoria continues on its quest to provide high quality training to meet the demand for skilled tradespeople. Each year the Victorian Department of Education and Training releases a Performance Summary Report for every Registered Training Organisation (RTO) and TAFE. The report provides the key performance measures across student experience, student outcomes and employer feedback.

In the Student experience category, satisfaction with training provided by NECA E&C was 83.3%, compared to the State average of 77.5%. In the Student outcomes category, satisfaction was an outstanding 92.7% - well above the State average of 73.5%. In addition, the proportion of VET students who would recommend NECA E&C to their colleagues was 85% compared to the Victorian State average of 76%. In the Employer feedback category, our employers have continued to express high levels of satisfaction (82%) with the training provided by NECA E&C compared to the average (78.5%).

Our focus remains on putting the student at the centre of everything we do, developing and supporting our teachers, while continuing to invest in our learning and practical resources.

This year was also very busy for the Industry Specialist Mentoring for Australian Apprentices (ISMAA) program team and mentors. We recruited 1,200 apprentices into the mentoring program in Victoria, providing ongoing support to a diverse range of individuals on their journey to become the next generation of A Grade Electricians. NECA Women's Network was re-launched in March 2019 after a three-year absence from NECA's Events calendar. The Network was successfully re-ignited to coincide with International Women's Day, attracting 100 female members and stakeholders in the electrotechnology industry. These events provide a platform for women to share knowledge and experiences working in a traditionally male dominated industry and take back tips, tools and resources to apply back to the business.

### Celebrating Excellence

The 2019 Excellence and Apprentice Awards maintained its position as the industry's biggest awards ceremony with around 750 industry representatives recognising the State's best electrotechnology projects.

There were 48 nominated projects (15% increase on 2018) across 13 categories. E&C also awarded 2 Apprentice Awards, 3 Apprentice Certificates of Achievement and 2 Apprentice Commendations for the State. We are proud to report that 3 of our Victoria Award winners went on to win National Excellence Awards and 2 received National Commendations. A big congratulations to the entire Victorian cohort!

# Membership Strong Despite Economic Climate

Membership numbers have remained steady for the past 12 months at around 1,400 members, a significant effort in the current economic climate, described by some industry veterans as the worst they have ever seen.

Despite this it has been pleasing to see an increasing number of members continuing to access the extensive range of technical, legal and safety services available as part of their membership.

Members continually rate technical information as the most important service to their business and NECA WA has been pleased to offer outstanding services in this area. The Technical Hotline received more than 13,000 calls in the past 12 months, in addition to 8,150 searches and 36,000 article views on the Technical Knowledge Base.

NECA Legal WA provided 900 hours of free legal advice to NECA members and collected more than \$300,000 of outstanding payments for members, free of charge.

The Safety team continues to provide valuable safety advice and support to members. Hundreds of 'Working Live Packs' were distributed to members to assist with adhering to the working live regulations and there was a 110% increase in the number of clients who achieved certification.

# Advocating on Behalf of Members

Advocating on behalf of members is one of NECA WA's most important activities. In the past year NECA WA has strengthened its relationships with stakeholder organisations, Government departments and State and Federal ministers, and we've had regular meetings to collaborate on industry issues and identify improvements that will benefit members.

At a state level, in 2019 we lobbied government, regulators and other industry associations on:

- Synergy's entry into the retail solar market
- The use of DC isolators on solar installations
- The definition of electrical work on solar installations
- The regular testing of electrical wiring in homes to prevent incidents
- The enforcement of two years' work experience before an electrical worker can gain an electrical contractor's licence
- Safe Working guidelines for electrical workers and apprentices
- Changes to the Apprenticeship Supervision Guidelines
- Communication regarding the placement of bonding points in swimming pools
- Acceptable methods for sealing switchboards
- Clarifying the requirements for electrical workers to have first aid qualifications

# **Events and Awards**

NECA WA continues to support the WA electrical industry by hosting events and seminars which provide members with learning and networking opportunities and celebrate industry achievements.

- In 2019, 2,175 people attended more than 40 NECA WA events, including 22 NECA Member Night Roadshows across the state and five Tech Talks.
- NECA WA coordinated and marketed the NECA National Conference in Hamilton Island, touted as the best NECA Conference ever held with 330 delegates from around the country in attendance.
- In the second half of the year NECA WA launched educational webinars, designed to provide regional members with access to some of our most popular technical information-based events.
- The fourth Future Leaders Program delivered 8 informative sessions to 12 participants.

We were pleased to acknowledge our most exceptional projects and apprentices at the NECA WA Excellence and Apprentice Awards in August. Congratulations to Calibre Electrical Contractors who won the 2019 NECA National Excellence Award in the Small Commercial category for Wickham Community Hub.

### **Training and Careers**

NECA WA works closely with EGT and CET to ensure industry has access to high quality training and apprentice employment options. EGT, CET and NECA WA were announced as joint recipients of the WA Industry Collaboration Award at the WA Training Awards. The prize was awarded for their Electrical Industry Female Participation Program (EIFPP) - recognising exemplary skills, development and collaboration between themselves, NECA members Bon Electrics and Williams Electrical, secondary schools and local employers to improve course accessibility and reduce barriers for female school students obtaining an apprenticeship.

The program provides a structured career pathway into the electrical industry, promotes the electrical industry as 'gender-neutral', and delivers a training experience aimed at giving students the best possible chance of employment.

EGT has had an improved year in 2019 with a number of notable achievements:

- Provided 261 host employers with quality apprentices
- Employed 163 new apprentices
- Produced 148 graduate electricians
- EGT apprentices were recognised by industry, featuring in the finals and winning places in a range of awards, including the NECA WA Apprentice Awards, WorldSkills Regional Competition and ANZETA Trans-Tasman Challenge 2019.

CET maintains a dominant position in industry training, with award-winning instructors and systems and resources that are in demand not only in Australia, but on an international level.

#### In 2019, CET:

- Trained half of WA's electrical mechanic apprentices
- Achieved an apprentice completion rate of 90%, well above the industry average of 70%
- Provided general and post-trade training courses to more than 4000 students
- Successfully lobbied the State Government to slash the course fees for UEE30811 Certificate III in Electrotechnology Electrician for 2020 and 2021.

I'd like to extend my thanks to our members, the NECA WA Board and committee members, industry stakeholders and sponsors for their ongoing support of NECA WA and the electrical industry. NECA WA continues to be the strongest member association for electrical contractors in WA.

# **Highlights and Initatives**

The past year has seen ongoing development of initiatives such as NECA's associated group training company, NECA Careers and Apprenticeships (NCA), which is without doubt one of the most significant projects undertaken by NECA SA/NT for many years, and one we firmly believe will provide significant benefits to NECA SA/NT Chapter members and industry more broadly.

NCA now employs 71 apprentices, one office administration trainee and three highly competent staff and will only continue to grow. This will ensure our members and the industry are supplied with quality apprentices who will receive the full range of training and achievement of competencies as required by the training packages and industry.

Increased activity in the Northern Territory has been reflected in our growing membership numbers across

the Territory. This includes delivery of an industry Roadshow Seminar, which has enhanced our profile with both industry and local government agencies.

### Advocating on Behalf of Members

The NECA SA/NT Chapter has continued to play a significant role in the SA building and construction industry alongside other sub-contractor associations through Specialist Contractors SA to collectively represent sub-contractors to industry and government and its relevant departments, which has included the provision of submissions in regard to Security of Payment and unfair contract matters where sub-contractors continue to be negatively affected.

The NECA SA/NT Chapter has also continued to take a lead role in the resolution of a major issue affecting our industry since the introduction of 'Metering Choice', which has caused significant disruption to the electrical connection process in South Australia. The recognition by AEMO and electricity retailers of the major role played by NECA SA/NT in this matter has been rewarding and hopefully duly acknowledged by industry generally.

Representation as Chair of the Electrotechnology Industry Reference Committee (IRC), which has carriage of the development and maintenance of our trade training programs for our sector, has resulted in a rise in work associated with the new training package development system. This is of critical importance to our industry.

Our industry representation has also included Director of Energy Skills Australia (E-Oz), Director of the Australian Refrigeration Council (national licensing regulator for the refrigeration and air conditioning industry), Director of the SA Portable Long Service Leave Board, Member of the Training and Skills Commission (TASC) Industry Skills Council, Member of the Construction Industry Training Board (CITB) Commercial Sector Committee and Chair of the national Industry Reference Committee (IRC) for the Electrotechnology sector.

We have also continued to provide representation and advocacy for the electrical and communications sectors with industry stakeholders such as the Office of the Technical Regulator, SA Power Networks, Office of Consumer & Business Services, SafeWork SA, ReturnToWork SA, Office of the Small Business Commissioner, Training and Skills Commission, Office of the Training Advocate, Office of the Industry Advocate, manufacturers and wholesalers.

# **Events and Networking**

2019 saw the delivery of another very successful Industry Roadshow series. NECA SA/NT staff and our industry partners travelled to all regions of the State providing information to industry. This continues to be the only source of continuous professional development for our industry in South Australia.

### **Training and Careers**

NECA facilitated a range of training seminars and workshops on topical issues such as Security of Payments, Business Management, Leadership and more. We are looking forward to delivering further training sessions for our members in 2020 and will be working closely with Master Plumbers Association SA and Air Conditioning and Mechanical Contractors Association SA to deliver seminars and workshops that will assist a broader range of subcontractors across South Australia.

# **Celebrating Excellence**

In 2019 the quality work of NECA SA members was recognised through the annual Excellence and Apprentice Awards. The event was well attended with outstanding feedback from members and sponsors. It was rewarding to see a number of SA projects take out a number of the top National Excellence and Apprentice Awards.

# Highlights and Initiatives

This year we saw considerable change across the State with NECA continuing to represent members and the broader electrotechnology industry through engagement with the Tasmanian Government and other key stakeholders.

Attendance at the NECA Annual Business Luncheon reflects the prosperous economic period we find ourselves in, with significant activity right across the building and construction sector. # Advocating on Behalf of Members

- Various safety related aspects of electrical work from Arc-Flash Awareness and Asbestos Awareness to Isolation Lockout and Electromagnetic radiation.

### Awards and Events

The 2019 NECA Annual Business Luncheon was a great success. These luncheons provide an opportunity for our members, business partners and representatives from across the electrotechnology industry in Tasmania to come together in support of the building and construction sector, as well as create and enhance business and networking opportunities. # ACRS Annual Report



The Australian Cabler Registration Service (ACRS) is Australia's second largest Registrar of Cablers - run by the industry, for the industry.

ACRS is a wholly owned and operated subsidiary of NECA and is licensed by the Australian Communications and Media Authority (ACMA).

In Australia, installation of any equipment that will be connected to the telecommunications network can only be performed by a technician with a current cabling registration. This includes cabling for monitored security alarms, closed circuit TV, telephone lines, internet connected computers, building automation and smart home systems.

ACRS advocates to the Communications Minister, ACMA and the NBN to address concerns raised by registered cablers and to ensure that ACMA regulations are effective in ensuring quality without being unduly restrictive on businesses. As one of the leading registrars of cablers in Australia, and part of NECA, ACRS is uniquely positioned to represent the interests of cablers across all States and Territories.

ACRS ensures that competency levels are appropriate for registered cablers to guarantee the high quality of cabling work across Australia and keeps its registered cablers up to date on the latest issues in this rapidly changing field of technology.

# 2019 ACRS Highlights:

- Increased cabler registrations to around 26,000 across Australia;
- Continued to lobby ACMA to encourage strengthening of regulatory controls and to ensure the communications industry remains strong and viable. With the development of new technologies customer cabling continues to be an integral part of the telecommunications network for the foreseeable future. Poor cabling practices could result in a lethal situation.

- Actively prepared cablers to meet ACMA competence requirements associated with the NBN, one of the biggest publicly funded infrastructure projects in Australia;
- Participated in major telecommunications and electronics industry conferences Integrate 2019 in Melbourne and Security 2019 in Sydney, both of which brought together renowned industry speakers, education programs and global product launches;
- Sponsored the NECA National Conference 2019, where ACRS gained access to more than 330 attendees to promote safe cabling practices and educate electrical contractors on the communications industry requirement for cabling registration.
- Topics of focus for ACRS have included Power over Ethernet (PoE) and home automation as well as a Home Wiring Essentials guide for consumers and Cabling Registration guide for electricians.
