

# **Introduction of ACT Award Categories.**

NECA ACT have opened this year's awards to more members and introduced categories that have particular relevance to contractors in the ACT.

## New categories are:

- <u>DOMESTIC RESIDENCE (Small)</u> for projects with a total contract value of less than \$100k
- COMMUNICATIONS/DATA SMALL (Voice/Data)— less than \$1m
- COMMUNICATIONS/DATA MEDIUM (Voice/Data)—projects between \$1m & \$2m
- COMMUNICATIONS/DATA LARGE (Voice/Data) projects greater than \$2m
- <u>SECURITY</u>—introduction of new ACT Award—This category is open to applicants installing electronic security systems in both domestic and commercial premises. EG: Intruder alarm, access control, CCTV, intercom, key management, perimeter detection, system integration.
- **FIRE**—introduction of new ACT Award—This category is open to applicants responsible for, but not limited to, the installation of Fire Protection, Fire Prevention and Suppression systems.

## In addition to the new categories:

- **INDUSTRIAL—SMALL, MEDIUM and LARGE** includes automation projects. Thereby the category includes, but is not limited to, undertakings of a civil, mining, high voltage, manufacturing, automation or process nature.
- **SMALL CONTRACING BUSINESS** with less than 10 employees. Includes Small Electrical/Manufacturing Businesses

# **Existing Categories remaining unchanged from previous years:**

- ENERGY EFFICIENCY AND ENVIRONMENT
- LIGHTING

## **Conditions of Entry:**

#### **GENERAL**

- All nominating companies must be current financial members of NECA ACT.
- Nominated projects must be completed (for projects to handover stage) after 1 July 2015.
- Entrants must adhere to the criteria of the category in which they enter.
- Entrants can enter no more than two projects per category.
- Projects may be entered into more than one category.
- The applicant must obtain assurance of the client's permission and cooperation in regard to access for judging and the use of photographs in their nomination.
- By entering a project you give NECA permission to use project details and photographs on the NECA Website, promotional material and media.
- You must identify in your submission of anyone in your company on a NECA Board.

#### **DOMESTIC RESIDENCE (Small)**

- This is an ACT specific subcategory introduced into the Domestic Category.
- National Representative will be selected at the Judge's discretion from nominations in both the small and general Domestic Category.
- Nominations to be submitted via the online nomination system under the Domestic Category.
- Judging shall be in accordance with existing Domestic Residence judging criteria.

#### COMMUNICATIONS/DATA—SMALL

- Known at the National Level as Voice/Data
- For projects with a value less than \$1m
- Nomination to be submitted via the online nomination system under Voice/Data with project cost clearly stated.
- National Representative will be selected at the Judge's discretion from the Small, Medium and Large categories.
- Judging shall be in accordance with existing Voice/Data judging criteria.

#### COMMUNICATIONS/DATA—MEDIUM

- Known at the National Level as Voice/Data
- For projects with a value greater than \$1m, but less than \$2m
- Nomination to be submitted via the online nomination system under Voice/Data with project cost clearly stated.
- National Representative will be selected at the Judge's discretion from the Small, Medium and Large categories.
- Judging shall be in accordance with existing Voice/Data judging criteria.

### COMMUNICATIONS/DATA—LARGE

- Known at the National Level as Voice/Data
- For projects with a value greater than \$2m
- Nomination to be submitted via the online nomination system under Voice/Data with project cost clearly stated.
- National Representative will be selected at the Judge's discretion from the Small, Medium and Large categories.
- Judging shall be in accordance with existing Voice/Data judging criteria.

#### **SECURITY**—Both Domestic and Commercial

- ACT Category only
- Winner will NOT PROGRESS to National Awards
- Open to applicants installing electronic security systems in both domestic and commercial premises. For example, intruder alarm, access control, CCTV, intercom, key management, perimeter detection, system integration.

#### FIRE

- ACT Category only
- Winner will NOT PROGRESS to National Awards
- This category is open to applicants responsible for, but not limited to, the installation of Fire Protection, Fire Prevention and Suppression systems.
