

Declaration as to the manner in which the alterations were made

I, Suresh Manickam, as the National Secretary of The National Electrical Contractors Association (the Association), am authorised to make this declaration.

1. The alterations to the rules of the Western Australian Chapter of the Association, as set out in the Notice of Particulars of Alterations at Annexure A to this declaration, were made in accordance with the rules of the Western Australian Chapter and in accordance with the national rules of the Association.
2. Action taken under the Western Australian Chapter rules to alter the Western Australian Chapter rules was as follows:
 - (i) pursuant to WA Chapter rule 15, the Chapter Secretary was in receipt of the notice of motion to amend the WA Chapter rules on 21 June 2016;
 - (ii) the notice of motion was issued by Notice of a Meeting to each member of WA Chapter Council on 21 June 2016;
 - (iii) on 26 July 2015 a duly held and quorate meeting of the WA Chapter Council, in consideration of a report/recommendation by the Executive, resolved unanimously in favour of the subject alterations.
3. Action taken under the National Rules of the Association to alter the Western Australian Chapter rules was as follows:
 - (i) pursuant to national rule 20(c) the subject WA Chapter rule alterations were approved by the National Executive Committee on 4 August 2016.
 - (ii) pursuant to national rule 38, new national rule 20A (being co-dependent on two of the subject WA Chapter rule alterations) was approved by the National Council on 17 November 2016.
 - (iii) I rely on the information contained in my declaration dated 25 November 2016 accompanying Notice of Particulars of Alteration to the national rules of the Association in respect of subparagraph 3(ii) above.
 - (iv) All ten members of Council were present in person at the meeting.
4. Notice that the subject rule alterations have been lodged with the Fair Work Commission has been published on the WA Chapter web site.
5. The particulars set out in this declaration are true and correct to the best of my knowledge and belief.
